

Please take notice that the following Ordinance was adopted on first reading by the Township Committee of the Township of Kingwood, County of Hunterdon and State of New Jersey at a meeting held on the 6th day of October, 2011. The Ordinance was then ordered to be published according to law. Notice is hereby given that the said Ordinance will be considered for final passage at a public hearing to be held on November 3, 2011 at a meeting beginning at 7:00PM at the Municipal Building located on the corner of County Road 519 and Oak Grove Road, Kingwood Township, New Jersey, at which time all interested persons will be heard.

ORDINANCE NO. 16 - 24 - 2011

AN ORDINANCE AMENDING ARTICLE I OF CHAPTER 34, "RECREATION COMMISSION AND PARKS AND RECREATION COMMITTEE" OF THE CODE OF THE TOWNSHIP OF KINGWOOD TO PROVIDE FOR FEES FOR PARK USAGE

WHEREAS, it has been recommended by the Kingwood Township Parks and Recreation Committee that a \$75 (seventy-five) fee be established for field usage at all Kingwood Township Parks; and

WHEREAS, it has been further recommended by the Kingwood Township Parks and Recreation Committee that the \$75 fee be waived in the case of field usage by organizations that are qualified under section 501 (c) (3) of the Internal Revenue Code of the United States of America; and

WHEREAS, the Township Committee has reviewed the recommendations of the Kingwood Township Parks and Recreation Committee and concurs with those recommendations; and

WHEREAS, it is in the best interests of the Township to codify existing fees that have been contained in prior resolutions, rules and regulations into Chapter 34 in order that all fees may be easily reviewed by members of the public.

NOW THEREFORE, BE IT ORDAINED, by the Mayor and Committee of the Township of Kingwood, County of Hunterdon as follows:

- 1) A \$75 (seventy-five) fee is established for field usage at all Kingwood Township Parks.
- 2) The \$75 fee shall be waived in the case of field usage by organizations that are qualified under section 501 (c) (3) of the Internal Revenue Code of the United States of America.
- 3) For non-residents of Kingwood Township, fees shall be paid for the use of the pavilion in Kingwood Park as follows:
 - \$250 for the use of the pavilion by no more than 50 persons for a maximum of 8

consecutive hours.

\$100 for the use of the pavilion by each additional 50 persons.

\$50 per hour for the use of the pavilion for each additional hour beyond 8 hours.

\$50 cancellation fee if a reservation for use of the pavilion is cancelled within 15 days of the scheduled event.

\$50 fee plus administrative costs for any returned checks.

- 4) All persons using any Kingwood Township Park shall provide proof of insurance as is more specifically described in the "Rules and Regulations" applicable to all Kingwood Township parks and facilities, attached hereto as Exhibit A, which were earlier adopted by the Township and are ratified and made a part hereof.
- 5) All of the provisions contained in Exhibit A, "Rules and Regulations" are hereby specifically ratified and made a part hereof.
- 6) If any part or parts of this ordinance are for any reason held to be invalid, such adjudication shall not affect the validity of the remaining portions of this ordinance.
- 7) All Ordinance or parts of ordinances which are inconsistent herewith are repealed, but only to the extent of such inconsistency. All other parts of the Code of the Township of Kingwood not inconsistent herewith are ratified and confirmed.
