NOTICE IS HEREBY GIVEN that sealed bids will be received by the Township Committee of the Township of Kingwood, Hunterdon County, New Jersey for a **DUMP TRUCK**. The work under this Contract **includes the purchase and delivery to the Township of a new 2012 Ford F-550 Super Duty XL regular cab (or equivalent), 4x4 dual rear wheel cab, chassis, dump body, spreader, plow and accessories.**
