OPEN PUBLIC MEETINGS ACT

WHEREAS, the Open Public Meetings Act (N.J.S.A. 10:4-6 et seq. hereinafter the "Act") provides for the giving of an annual notice by public bodies of a schedule of the succeeding year, including the location of each meeting to the extent it is known, and the time and date of each meeting; and

WHEREAS, the Act authorized a public body to make certain other determinations and to take certain other actions in conformance therewith;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Kingwood, County of Hunterdon, State of New Jersey as follows:

1. Regular meetings of the Township Committee shall be held during the 2011 calendar year at 7:00 P.M. prevailing time, on the **first Thursday** of each month at the Municipal Building located on County Route 519 and Oak Grove Road in Kingwood Township, New Jersey, unless rescheduled in conformity with the said Act.

2. 3. The following newspaper is hereby designated as alternate newspaper to receive any of the notices described in paragraph 2 above in the event that either or both of the newspapers designated in paragraph 2 shall be unavailable to receive or publish such notices within the time requirements of the Act due to weekly publishing schedules:

a. The **Express Times**, which is hereby determined to be the alternate newspaper which has the greatest likelihood of informing the public of this municipality of meetings of this public body and may be utilized when necessary to receive such notices in order to conform to the maximum extent possible with the time and the notice requirements of the Act.

4. This public body shall keep reasonably comprehensible minutes of all of its meetings showing the time and place, the members present, the subjects considered, the actions taken, the vote of each member and any other information required to be shown in the minutes by law, which shall be promptly available to the public to the extent that making such matters public shall not be inconsistent with Section 7 of the Open Public Meetings Act (R.S. 10:4-12).

RATE OF INTEREST ON DELINQUENT TAXES

WHEREAS, N.J.S.A. 54:4-67 permits the governing body of each municipality to fix the rate of interest to be charged for non-payment of taxes or assessments subject to any abatement or discount for the late payment of taxes as provided by law;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Kingwood, County of Hunterdon, State of New Jersey as follows:

The Tax Collector is hereby authorized and directed to charge 8% per annum of the first \$1,500.00 of taxes becoming delinquent after due date and 18% per annum on any amount of taxes in excess of \$1,500.00 becoming delinquent after due date until all delinquency is made current and if a delinquency is in excess of \$10,000.00 and remains in arrears beyond December 31st, an additional penalty of 6% shall be charged against the delinquency.

BE IT FURTHER RESOLVED by the Township Committee of the Township of Kingwood, County of Hunterdon, State of New Jersey as follows:

No interest shall be charged if any payment of any installment is made within ten (10) days after the date upon which the same became payable according to the laws in cases made and provided. If such payment is not made within the ten (10) day grace period, the above rates of interest shall run and accrue from the original due date of such taxes.

Comments from Mayor and the Township Committee

Mayor Phillip Lubitz

I would like to thank the citizens of Kingwood Township for their trust in bestowing this great honor on me. I would like to thank my wife Barbara for her support and the extra hours she has spent in caring for our family, which has allowed me to devote time to the public service. I would also like to thank Jim Burke and Elaine Niemann for their collegiality and the examples of selfless service to the community that they have demonstrated. Our Kingwood Township staff, Mary, Diane and Cindy who consistently go above and beyond the call of duty and without whom township government would come to a halt, and the many volunteers who put in hundreds of hours of uncompensated service to the township. In Kingwood Township we have an extraordinary opportunity to continue moving towards the ideal as expressed by Abraham Lincoln, a “government of the people, by the people, for the people”. At this time more than ever it is essential that government take affirmative steps to assure that it is inclusive, above reproach and attentive to the will of the people. In keeping with this theme I will propose that during the next year, we adopt ordinances that make ethics training mandatory for all township elected officials and employees and to provide similar training to township volunteers. To prohibit elected officials from receiving township paid health benefits, because serving on the township committee should be considered public service and not a vocation. We have begun and will continue a process of rebidding the township’s professional services every three years on a rotating basis. I will look for agreement from my colleagues that the township will post all ordinances on our web site prior to their being brought to a vote by the township committee. My additional hope is that prior to the end of my term as Mayor that all current township ordinances will be available on our website. Our township residents are demanding that we keep Kingwood Township affordable and at the same time maintain our rural character. The ongoing recession has hit particularly hard on the many township residents who are involved in the building trades and those who are on fixed incomes. Seniors on Social Security received no cost of living increase in the last year and also had their senior rebate taken away. The Star Ledger reported this week that the average municipal tax levy increased by 5% this year. To our credit Kingwood increased by .07%, less than 1%. I would like to see us do better. I am inviting township residents to propose areas in which the township can save money or offset expenses.

To assist in this I will work with our auditor and CFO to see if we can post past, current and projected budget information on our web site. I am asking department heads and committee chairs to plan for expenditures that are in line with the lesser of FY10 budgeted or actual expenses. We will continue our commitment to maintaining the rural character of Kingwood Township that we all love. This is a place of exceptional natural beauty. With that said we cannot ignore the role that additional ratables play in allowing many of us to continue to be able to afford to live here. We need to explore ways by which we can encourage reasonable development, development without sprawl that supports and maintains Kingwood's rustic charm and affordability. Staying exactly as we are without ever increasing taxes is not an option. I invite all interested parties to engage in a responsible discussion on how we can best accomplish these two seemingly conflicting goals.
