**ORDINANCE NO. 19 - 12 - 2018**

**AN ORDINANCE AUTHORIZING A SPECIAL EMERGENCY APPROPRIATION PURSUANT TO N.J.S.A. 40A:4-53 FOR THE PREPARATION OF A MASTER PLAN OR PLANS**

**IT IS HEREBY ORDAINED** by the Township of Kingwood, County of Hunterdon, State of New Jersey, as follows:

**SECTION 1.** Pursuant to the authority of N.J.S.A. 40A:4-53, the sum of \$26,000.00 is hereby appropriated for the preparation of a digitized tax map and shall be deemed a special emergency appropriation as defined and provided for in N.J.S.A. 40A:4-55.

The authorization to finance the appropriation shall be provided for in succeeding annual budgets by the inclusion of at least one-fifth (1/5<sup>th</sup>) of the amount authorized pursuant to this Act.

**SECTION 2. Severability.** If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to that section, paragraph, subdivision, clause or provision, and the remainder of this Ordinance shall be deemed valid and effective.

**SECTION 3. Repealer.** All Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**SECTION 4. Effective Date.** This Ordinance shall take effect immediately upon final passage and publication according to law.
