

ORDINANCE NO. 20 – 26 - 2019

AN ORDINANCE AMENDING CHAPTER 75A-2 - FEES

WHEREAS, the Township Committee desires to amend Section 75A-2 of the Ordinances of the Township of Kingwood to amend the fee for a Certificate of Redemption.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Township Committee of the Township of Kingwood the Township of Kingwood, County of Hunterdon, State of New Jersey as follows:

Section 1:

Chapter 75A-2 K(1) – Certificate of redemption of sales certificate: \$50 shall be deleted in its entirety.

Section 2:

If any part or parts of this ordinance are for any reason held to be invalid such adjudication shall not affect the validity of the remaining portions of this ordinance.

Section 3:

All ordinances or parts of ordinances which are inconsistent herewith are repealed but only to the extent of such inconsistency. All other parts of the Code of the Township of Kingwood not inconsistent herewith are ratified and confirmed.

Section 4:

This Ordinance shall take effect immediately upon final adoption and publication according to law.

PLEASE TAKE NOTICE that the following Ordinance was adopted on first reading by the Township Committee of the Township of Kingwood, County of Hunterdon and State of New Jersey at a meeting held on the 5th day of September, 2019. The Ordinance was then ordered to be published according to law. Notice is hereby given that the said Ordinance will be considered for final passage at a public hearing to be held on 3rd day of October, 2019 at a meeting beginning at 7:00 PM at the Municipal Building located on the corner of County Road 519 and Oak Grove Road, Kingwood Township, New Jersey, at which time all interested persons will be heard.
