

ORDINANCE NO. 20 - 19 - 2020

AN ORDINANCE TO PROVIDE FOR THE PURCHASE OF A CASE 580SN WIDE TRACK BACKHOE WITH 4WD, CAB AIR CONDITIONING, 4 IN 1 BUCKET, 24” BUCKET, HYDRAULIC THUMB, RIDE CONTROL, PILOT CONTROLS, DELUXE SEAT AND FLIP PADS OR EQUIVALENT AS A GENERAL IMPROVEMENT FOR THE TOWNSHIP OF KINGWOOD IN THE COUNTY OF HUNTERDON AND STATE OF NEW JERSEY AND APPROPRIATING \$120,000.00 FROM THE CAPITAL IMPROVEMENT FUND – RESERVE FOR PURCHASE OF MUNICIPAL EQUIPMENT AND THE CAPITAL IMPROVEMENT FUND

BE IT ORDAINED by the Township Committee of the Township of Kingwood, in the County of Hunterdon, State of New Jersey as follows:

SECTION 1. The improvement described in Section 2 of this ordinance is hereby authorized as a general improvement to be made or acquired by the Township of Kingwood, New Jersey. For the said improvement or purposes described in Section 2, there is hereby appropriated the sum of \$30,000.00 from the Capital Improvement Fund – Reserve for Purchase of Municipal Equipment and \$90,000.00 from the Capital Improvement Fund, said sum being inclusive of all appropriations heretofore made therefore.

SECTION 2. The Township of Kingwood is hereby authorized to purchase a **CASE 580SN WIDE TRACK BACKHOE WITH 4WD, CAB AIR CONDITIONING, 4 IN 1 BUCKET, 24” BUCKET, HYDRAULIC THUMB, RIDE CONTROL, PILOT CONTROLS, DELUXE SEAT AND FLIP PADS OR EQUIVALENT.**

SECTION 3. In order to finance the cost of the improvements or purpose there is hereby appropriated \$30,000.00 from the Capital Improvement Fund – Reserve for Purchase of Municipal Equipment and \$90,000.00 from the Capital Improvement Fund.

SECTION 4. The said purpose described in Section 2 of this ordinance is not a current expense and is an improvement which the Township may lawfully acquire or make as a general improvement.

SECTION 5. The capital budget of the Township of Kingwood is hereby adopted to conform with the provisions of this ordinance.

The resolution in the form promulgated by the Local Finance Board showing full detail of the capital budget as approved by the Division of Local Government Services in on file with The Clerk and is available there for public inspection and to be included in the capital budget for the 2020 budget.

SECTION 6. There is no debt authorized for this improvement or purpose.

SECTION 7. This ordinance shall take effect immediately upon final passage according to law.
