

ORDINANCE NO. 21 – 07 - 2021

AN ORDINANCE PROVIDING FOR THE APPROPRIATION FOR THE COST OF THE ACQUISITION OF BLOCK 33, LOT 25, APPROPRIATING \$654,311.70 THEREFOR FROM A GRANT IN THE AMOUNT OF \$327,155.85 FROM NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION, GREEN ACRES AND THE HUNTERDON COUNTY OPEN SPACE ACQUISITION ASSISTANCE GRANT PROGRAM IN THE AMOUNT OF \$327,155.85.

BE IT ORDAINED by the Township Committee of the Township of Kingwood, in the County of Hunterdon, State of New Jersey, as follows:

SECTION 1. The improvement described in Section 3 of this ordinance is hereby authorized as a general improvement to be made or acquired by the Township of Kingwood, New Jersey. For the said improvement and purposes described in Section 3, there is hereby appropriated the sum of \$654,311.70 said sum being inclusive of all appropriations heretofore made therefor.

SECTION 2. In order to finance the cost of the improvements and purpose there is hereby appropriated the sum of \$654,311.70 which is being funded by a grant from the New Jersey Department of Environmental Protection, Green Acres, in the amount of \$327,155.85 and the Hunterdon County Open Space Acquisition Assistance Grant Program in the amount of \$327,155.85.

SECTION 3. The improvement hereby authorized is the acquisition of Block 33, Lot 25 on the tax map of the Township consisting of 103.859 acres in Kingwood Township, including all costs necessary therefore or incidental thereto.

SECTION 4. The said purpose described in Section 3 of this ordinance is not a current expense and is an improvement which the Township may lawfully acquire or make as a general improvement.

SECTION 5. The capital budget of the Township of Kingwood is hereby amended, to conform with the provisions of this ordinance to the extent of any inconsistency herewith. The resolution in the form promulgated by the Local Finance Board showing full detail of the amended capital budget as approved by the Division of Local Government Services is on file with the Clerk and is available there for public inspection.

NOTICE is hereby given that the foregoing Ordinance was introduced to pass on first reading at a regular meeting of the Committee of the Township of Kingwood held on March 4, 2021 and ordered published in accordance with the law. Said Ordinance will be considered for final reading and adoption at a regular meeting of the Township Committee to be held on April 1, 2021, at 7:00 PM, or as soon thereafter as the Township Committee may hear this Ordinance at the Municipal Building, 599 Oak Grove Road, Frenchtown, New Jersey, at which time all persons interested may appear for or against the passage of said Ordinance.
