

**ORDINANCE NO. 20 – 09 -2019**

**ORDINANCE AMENDING CHAPTER 132 “ZONING,” ARTICLE I “GENERAL PROVISIONS,” SECTION 6 “PROHIBITED USES” TO CORRECT INCONSISTENCY RELATED TO LICENSING OF KENNELS.**

**WHEREAS**, Section 132-6(E) states that Kennels are prohibited, but Section 57-9 provides for kennel licenses creating an inconsistency in the Code; and

**WHEREAS**, the Township Committee wishes to amend Section 132-6(E) of the Ordinance to correct an inconsistency.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Committee of the Township of Kingwood, County of Hunterdon, State of New Jersey as follows:

Section 1:

Section 132-6(E) shall be amended as follows:

E. Kennels for the breeding and/or boarding of dogs, except those licensed pursuant to Section 57-9.

Section 2:

If any part or parts of this ordinance are for any reason held to be invalid such adjudication shall not affect the validity of the remaining portions of this ordinance.

Section 3:

All ordinances or parts of ordinances which are inconsistent herewith are repealed but only to the extent of such inconsistency. All other parts of the Code of the Township of Kingwood not inconsistent herewith are ratified and confirmed.

Section 4:

This Ordinance shall take effect immediately upon final adoption and publication according to law.

NOTICE is hereby given that the foregoing Ordinance was introduced on first reading at a regular meeting of the Kingwood Township Committee of the Township of Kingwood, County of Hunterdon held on the 7<sup>th</sup> day of March 2019. The Ordinance was then ordered to be published accordance with the law. The said Ordinance will be considered for final reading and adoption at a regular meeting of the Township Committee to be held on the 4<sup>th</sup> day of April, 2019 at 7:00p.m. or as soon thereafter as the Township Committee may hear this Ordinance at the Municipal Building located at 599 Oak Grove Road, Frenchtown, New Jersey, at which time all persons interested may appear for or against the passage of this Ordinance.
